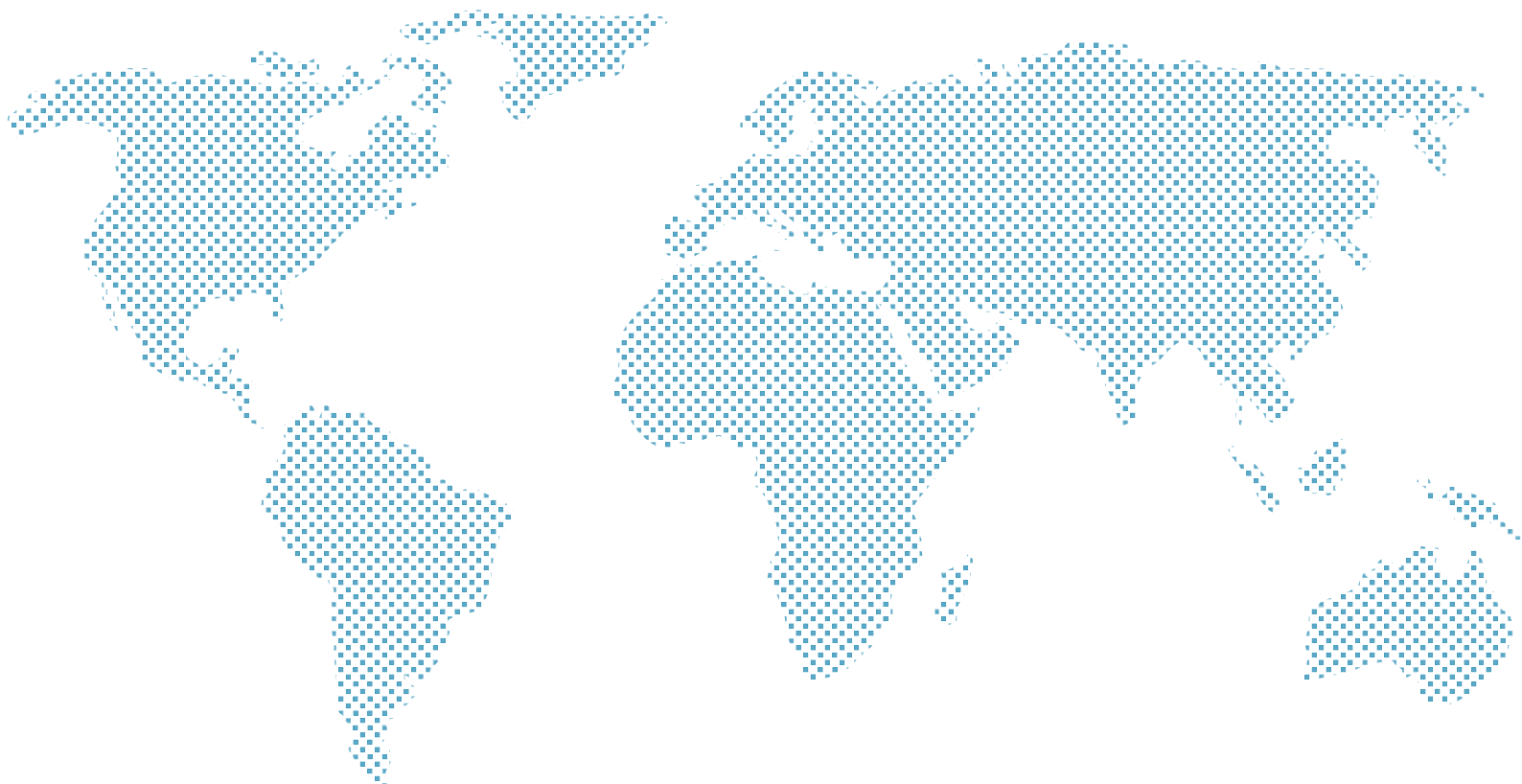

RESULTS METHODOLOGY

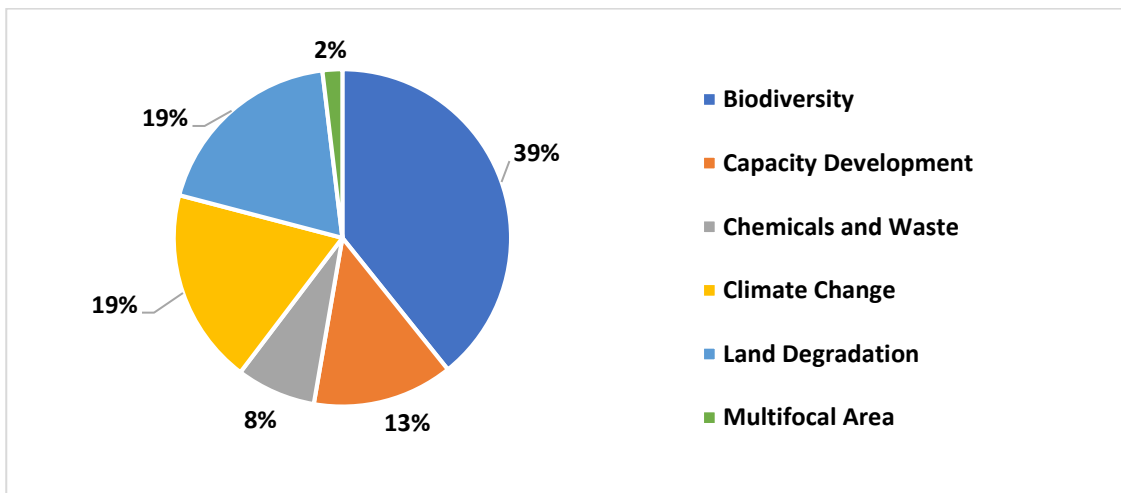

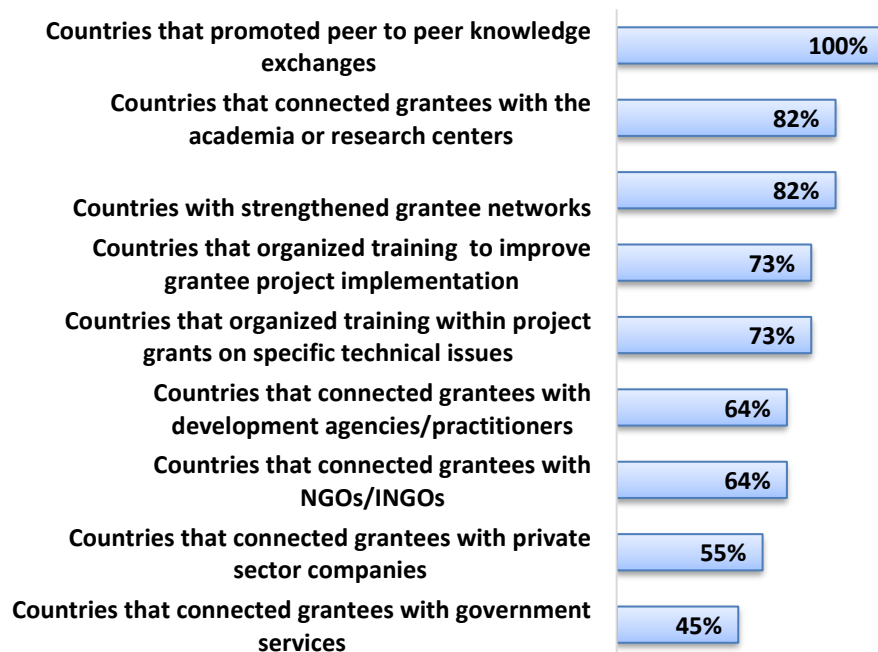

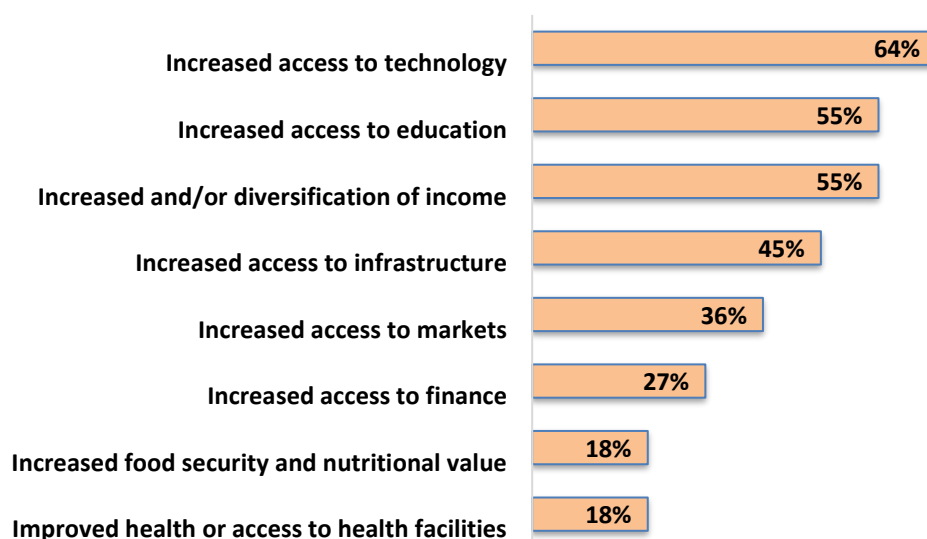
